The Right to Information Act, 2005 (22 of 2005) has been enacted by the Parliament and has come into force from 15 June 2005. This Act provides for right to information for citizens to secure access to information under the control of public authorities in order to promote transparency and accountability in the working of every public authority. According to UGC guidelines all Universities and colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government shall come within the purview or public Authority under this Act, Since **Dnyanjyoti Shikshan Prasarak Mandal's Siddharth Mahavidyalaya And Shikshan Prabodhini, Nanded. On 15th June 2005 The Right To Information Act 2005 was passed by the parliament It came into force on 12th October, 2005. Any citizen of India may request information from a "public authority" under the provisions of this Act (a body of Government or "instrumentality of state"). It required replying expeditiously or within 30 days. The Act also requires every public authority to computerize their records for wide dissemination and proactively certain categories of information so that the citizens need minimum recourse to request for information formally. Siddharth Mahavidyalaya And Shikshan Prabodhini, Nanded. has declared as a "Public Authority" under this Act as the implementation of "The Right To Information Act, 2005". The Act Commands that organization define as "Public Authorities" are obliged to make available information to the community and generate require preparation in order to encourage clearness and liability in the working for each public right. According to it some provisions of this act have come into effect instantly on its performance. An officer has been designated as a Public Information Officer (PIO) in pursuance of the Right to Information Act 2005. PIO shall perform the duties and responsibilities as predicted under the act without fail. This kind of information shall be presented to the community at large through the website. 
